The school undertakes to abide by the provisions contained in the affiliation & examination bye-laws, directions issued from time to time and law of the land.
9. That School will ensure compliance of all statutory requirements like, EPF, ESI and Labour Laws etc. With respect to the school and staff of the school.

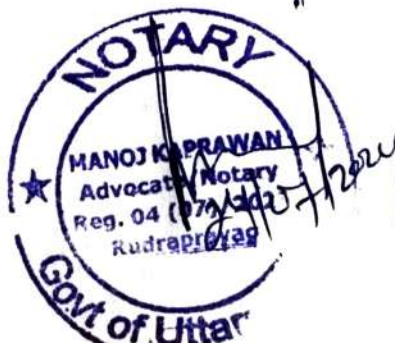
